**Across a 64-county area that includes the western half of Kentucky and part of southern Indiana, the council served more than 9,600 girl members ages 5-17 and 5,000 adult members. Our program priorities challenge girls to Discover, Connect and Take Action in their communities and in their lives. In 2020 our accomplishments can be measured by the successes of our girls. Even with activities severely restricted by 9-months of the COVID pandemic, GSK was home to 14 Gold Award Girl Scouts, 47 Silver Award Girl Scouts, 73 Bronze Award Girl Scouts, and sellers of 1.4 million boxes of cookies. The Council had record high girl retention in 2020, indicative of girl and leader satisfaction with our hundreds of programs and leadership opportunities.**
