**Across a 64-county area that includes the western half of Kentucky and part of southern Indiana, the council served 12,000 girl members, ages 5-17, and 5,500 adult members. Our program priorities challenge girls to Discover, Connect and Take Action in their communities and in their lives. In 2016 our accomplishments can be measured by the success of our girls. GSK was home to 22 Gold Award recipients, a state finalist Lego Robotics Team and sellers of 1.9 million boxes of cookies. As part of building our capacity to serve more girls and millennial volunteer leaders, GSK was an early adopter of the GSUSA Customer Engagement Initiative, an integrated CRM, volunteer and program management system. During 2016 GSK provided financial assistance to 1,985 girls who could not otherwise afford the Girl**
